Belonging to real and legal persons operating in the private sector and public sector, where conformity assessment services are provided; All information, data and documents obtained during the services provided, except for the part requested by the authorized institution(s) and accreditation institution(s), cannot be given to third parties or published in public channels for any purpose without the written consent of the right holder. Confidentiality of information, data and documents belonging to real and legal persons to whom service is provided is under the responsibility of TÜV AUSTRIA MARINE's senior management and this confidentiality will be fully respected.

The information obtained during the conformity assessment process is kept by TÜV AUSTRIA MARINE as the customer's secret, unless otherwise stipulated by law. When requested by the legal authority, TÜV AUSTRIA MARINE notifies the customer about the information it has given to the legal authority, unless legally prohibited from reporting it. Information obtained about the customer from sources other than the customer will be considered confidential.

TÜV AUSTRIA MARINE has established appropriate communication processes for all its personnel. It ensures effective communication for the smooth functioning of the management system.

TÜV AUSTRIA MARINE does not engage in any activity that would undermine confidence in independence, competence, impartiality, decision-making or honesty in its work.

All measures have been taken by the senior management of TÜV AUSTRIA MARINE against risks that may threaten the financial impartiality of the personnel and external auditors/experts involved in the conformity assessment process. Salaries of personnel, external auditors and experts are paid regardless of conformity assessment results.

There is not and will not be any commercial relationship, other than the scope of the service provided, between TÜV AUSTRIA MARINE and all real and legal persons and sectors for which conformity assessment services are provided.

All TÜV AUSTRIA MARINE employees report their past work experience to TÜV AUSTRIA MARINE. Employees who have provided any consultancy, training services or worked personally in the past two years or whose first-degree relatives are determined to be directly responsible are not assigned to the conformity assessment services of the relevant institution.

Under no circumstances will there be a commercial relationship between TÜV AUSTRIA MARINE company partners and all managerial personnel and all real and legal persons and sectors for which conformity assessment services are provided, outside the scope of the service provided. TÜV AUSTRIA MARINE will not be a part of design, production, assembly, distribution or maintenance activities of the product to be inspected for certification; will not be a part of design, implementation, operation or maintenance activities of the process to be inspected for certification and also will not be a part of design, implementation, control and maintenance activities of the service to be inspected for certification.
