

TÜV AUSTRIA MARINE attaches importance to the security and privacy rights of the information of all customers it communicates with. Within the framework of these rules, TÜV AUSTRIA MARINE has preferred to convey how it will use its customer information, how and under what conditions it will be shared via the website.

The purpose of these rules is to demonstrate how we will use your information and your rights regarding it.

### **DOES TÜV AUSTRIA MARINE SHARE THE INFORMATION RECEIVED FROM YOU?**

Information about our customers is an important part of our business and TÜV AUSTRIA MARINE does not sell this information to others. TÜV AUSTRIA MARINE shares personally identifiable information only as follows:

1. Transfer to personnel, committee members, subcontractors or subcontractors performing certain activities on behalf of TÜV AUSTRIA MARINE, e.g. receipt and delivery of samples, fulfillment of audit requests, sending e-mails, removing duplicate information from customers' lists, credit card payments and processing and performing operations such as data analysis. Such third party institutions only have access to the information necessary to carry out the relevant activities and cannot use this information for other purposes. TÜV AUSTRIA MARINE secures such information through contracts with third parties.
2. For whatever reason, under the sole responsibility of TÜV AUSTRIA MARINE, we believe that it is right to do the following; to meet information requests for the purpose of fulfilling the requirements of law, regulation or government or legal requests; Sharing information that enables the identification of the person in order to take legal action against persons who violate TÜV AUSTRIA MARINE's access rules or other rules, or to protect TÜV AUSTRIA companies.
3. The customer information (including your complaints and objections) that we obtain from different sources than our customers is evaluated within the scope of complete confidentiality and is kept as confidential information.
4. All information is considered as proprietary information and is considered confidential except for the information made public by our customers or agreed between TÜV AUSTRIA MARINE and the customer (for example, for the purpose of responding to complaints)

### **HOW DOES TÜV AUSTRIA MARINE PROTECT YOUR INFORMATION?**

To prevent unauthorized access, we enforce strict security rules regarding the storage and sharing of information you provide to us.
